I, Gary L Daniels declare that I am domiciled in Ward _____ in the City
(print name as it should appear on ballot-RSA 655:14-b)
(or Town or Unincorporated place) of Milford, County of Hillsborough state
of New Hampshire, and am a registered voter herein; that I am a registered member of the Republican
party; that I am a candidate for nomination for the office of State Representative from
Hillsborough County, District No. 43, to be made at the primary election to be held on
September 10, 2024; and I hereby request that my name be printed on the official primary ballot of the party in
which I am registered as a candidate for such nomination. I declare that I am not a candidate for incompatible
offices as defined in RSA 655:10 and that I am not a federal employee which makes me ineligible to file as a
candidate for this office. If I have been convicted of a felony, I declare that I have completed my sentence as
required in RSA 607-A:2. I further declare that, if nominated as a candidate for said office, I will not withdraw; and
that, if elected, I will be qualified for and will assume the duties of said office.

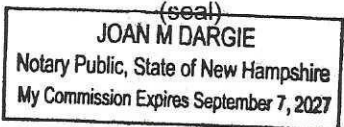
I, Gary L Daniels candidate for the office of representative from district No.
